ADMINISTRATIVE ORDER No. 9 / 2023

Reinstatement of the Board of Directors, General Manager, and Deputy General Manager, Ivory Bank

In light of the Legal opinion from Ministry of Justice and following the consultations with major shareholder of Ivory Bank (*the Government of South Sudan*) represented by the Ministry of Finance and Planning and the recommendation therein, and in exercise of the powers conferred upon me under Article 70 (3) (b) of the Bank of South Sudan Act 2011, and the Banking Act 2012, Article 116 (1). I, Hon. Dr. James Alic Garang, Governor of the Bank of South Sudan do hereby issue this Administrative Order, for the reinstatement of the Board of Directors, General Manager, and Deputy General Manager, as follows: -

1. Mrs. Bruna Siricio Iro - General Manager
2. Mr. Biar Kon Biar - Deputy General Manager
3. Board of Directors - 11 Members as per Annex 1 attached.

The reinstatement of the above individuals is for a period of six (6) months, to allow the Board of Directors and the Management to prepare audit and authorize Financial Statements for the years 2020-2021 and 2021-2022 respectively and conduct the General Assembly and shareholders meeting within the timeline given. During this period the Bank of South Sudan through the Supervision Department will closely monitor any progress made and discharge its mandate when deemed necessary.

This Administrative Order shall come into force as from the date of its signature by the Governor of Bank of South Sudan.
